

Quilt Expo Raffle Contest Rules

1. **HOW TO ENTER:** Quilt Expo Raffle tickets will be available ONLY at the 3-day Quilt Expo event held in the Exhibition Hall at the Alliant Energy Center in Madison, Wisconsin, Sept. 7, 8 and 9, 2017. A total of 8,000 pre-printed tickets will be available for \$2 each or \$5 for 3 tickets. There is no limit to the number of tickets an individual may purchase. *The raffle will close either when all 8,000 tickets have been sold or on September 9, 2017 at 3:15 p.m., whichever occurs first.*
2. **ODDS:** Odds of winning any single prize are 1 in 8,000.
3. **ELIGIBILITY:** The winner must be 18 years of age or older and a resident of the United States in a locale whose laws do not specifically prohibit such contests.
